**S.R.O. 1152 (I)/2025**.- In exercise of the powers conferred by sub-section (3) of section 18 of the Customs Act, 1969 (IV of 1969) and in supersession of its Notification No. S.R.O. 928(I)/2024, dated the 30<sup>th</sup> June, 2024, the Federal Government is pleased to levy regulatory duty on import of goods specified in column (3) of the Table below, falling under the PCT Code of the First Schedule to the said Act specified in column (2) of the said Table, at the rates specified in column (4) thereof, namely: -

- 2. The regulatory duty shall not be levied on the following, namely: -
  - (a) import under Notification No. S.R.O. 678 (I)/2004 dated the 7<sup>th</sup> August, 2004;
  - (b) import under Chapter 99 of First Schedule of the Customs Act, 1969 (IV of 1969);
  - (c) import under Fifth Schedule to the Customs Act, 1969 (IV of 1969), excluding serial no 22 and 23(v) of Table to Part I, serial numbers 99,100, 102, 116(iv) and (xvi),146 and 154 of the Table to Part-III of the said Schedule, subject to fulfilment of conditions laid therein;
  - (d) import under Temporary Importation Scheme vide Notification No. S.R.O. 492(I)/2009, dated the 13<sup>th</sup> June, 2009;
  - (e) import of special steel round bars and rods of non-alloy steel of diameter 50mm and exceeding 50mm (PCT code 7214.9990) by the seamless pipes manufacturers registered under the Sales Tax Act, 1990;
  - (f) import of Grain and non-grain oriented electrical steel sheets (PCT codes 7225.1100, 7225.1900, 7226.1100 and 7226.1900) under Sr. Nos. 6, 7 and 8 of S.R.O.565(I)/2006 dated 5<sup>th</sup> June, 2006;
  - (g) import of Rubber Apron and Cots (PCT code 4016.9990);
  - (h) import of vehicles (CBU) by new entrants, as enumerated vide Sr.1, Table-III of Notification No. SRO 656(I)/2006, in terms of Auto Development Policy; and
  - (i) import of input materials used for manufacturing of auto parts by local vendors under Notification No. S.R.O.655(I)/2006, dated the 5<sup>th</sup> June, 2006.

3. Rate of regulatory duty on import of CKD/SKD kits, of home appliances, mentioned in the Table, and of which kits are not specified separately therein, shall be five per cent.

4. Regulatory duty on import of Pine nut (chilgoza) falling under PCT code 0802.9100,0802.9200, 0802.9900 and marble (crude or roughly trimmed) falling under PCT code 2515.1100 shall be exempted and regulatory duty on import of ground nuts in shell falling under PCT code 1202.4100 shall be reduced to 10%, if imported from the

Islamic Republic of Afghanistan.

5 For the purpose of levy of regulatory duty under this Notification, the value of vehicles (PCT Code 87.03) having bullet proofing and other security features shall be the same as determined under Notification No. S.R.O.No.1121(I)/2007, dated the 17<sup>th</sup> November, 2007.

6. This Notification shall take effect from the 1<sup>st</sup> day of July, 2025 and if not rescinded earlier, shall remain in force till the 30<sup>th</sup> June, 2026.
