**SUBJECT: COMPETITIVENESS AND EFFICIENCY IMPROVEMENT EXERCISE BUDGET YEAR 2026-27**

In order to enhance competitiveness, rationalize cost of doing business of the Engineering Industry and to position it as a major player of the economy, the Engineering Development Board has initiated Competitiveness and Efficiency Improvement Exercise for the Fiscal Year 2026-27, under the following objectives/ guiding principles:

1. Encourage local manufacturing & sustainable growth
2. Removal of tariff anomalies between raw materials & finish goods
3. Rationalization of duties i.e. CD, ACD and RD
4. Creation of new tariff lines in line with industry requirements
5. Promotion and enhancement of exports

All stakeholders are requested to prepare and submit their proposals strictly on the enclosed prescribed proforma (**Annexure-I** and **Annexure-II**) in **MS Excel format only** (no other format shall be accepted) and forward the same to EDB **positively by 30.01.2026**. While formulating proposals, stakeholders are advised to carefully review the prevailing customs tariff structure, relevant laws, SROs, and in particular the provisions of the National Tariff Policy 2025-30 (NTP 2025-30).

03. It is further emphasized that all proposals must be adequately supported with relevant statistical data and market-based justification. **Any proposal without proper justification and information/ data as per attached format shall not be considered.**
